# PASS IN REVIEW



Thanks to all who attended our annual meeting and to those who were elected to positions with-in the 2<sup>nd</sup> Wisconsin Vol. Inf. Association. I look forward to working with you as I continue my service with the 2<sup>nd</sup> as your Lieutenant Colonel. To those who are given much, much is expected. These sesquentsentenial years of the American Civil War will prove to be challenging as we prepare and participate.

A few items will need to be addressed as we prepare for the 150<sup>th</sup> Bull Run event at Manassas this year. Be sure to keep updated. The registration for the 2<sup>nd</sup> Wisconsin Regiment will be conducted through John Dudkiewicz jjdudkie@charter.net. There is a \$20 registration fee and this should be sent to John along with the registration form. (His address is: 605 Ridgeview Dr., Onalaska, WI 54650). For forms and information check the web site for the event at www.visitpwc/reenactment/index.html you will be required to sign a waiver and carry a medical form on you during the event.

The 2<sup>nd</sup> Wisconsin Association will be chartering a bus and you will need to sign up for that as well. Each company should pull together their numbers and contact Dave Sielski <u>dseilski@greenbay.gannet.com</u> There will be deadlines to be met so lets not squander time by not getting registered and deposits in.

Manassas: As we are preparing for this event we must be aware of the time frame in which we are to participate. Because we are members of the Black Hat Battalion, we will be organized under the Cumberland Guard's command structure; Dave Shakleford commanding. Unfortunately for us, as the 2<sup>nd</sup> Wisconsin, the Cumberland Guard has been designated as the 1<sup>st</sup> Minnesota for this event. This makes me slightly upset. I am assured that our uniforms will not disrupt any scenario plan and that we may continue to wear our chosen Wisconsin gray uniforms. Col. DeCraine is pushing for all units to fall in wearing some sort of gray uniform. Battle shirts and frock coats should be prevalent.

While we will not be given a specific special spotlight, we will personally portray the 2nd Wisconsin along with our pards from the Black Hat Battalion under Col. Craig DeCraine. We will be falling in under our grand banners, and proudly honor those from our State who were there. The mix of militia and early war uniforms across all the participating units will certainly give us a first hand experience of the confusion and spectacle that our boys encountered. Col. DeCraine knows that we are the only unit that was actually at the battle from the BHB. Because of this, we will set aside part of the event for a ceremony in remembering the Second Wisconsin. [Three cheers!] As I see it, we need direction in uniform and equipment. Here are my requests for the 150<sup>th</sup> Manassas/Bull Run event:

<u>Recommend:</u> The uniform of Co. B 2<sup>nd</sup> Wisconsin (1861) Gray frock coat and trousers, gray forage cap and a white haversack with closers like that of photo of 2<sup>nd</sup> Wisconsin bugler. Weapon and accruements will be the 3 band Springfield or Enfield with black waist belt, cartridge box and sling as per 2<sup>nd</sup> Wisconsin requirements.

<u>1<sup>st</sup> Alternate:</u> Period correct shirt, (gray preferred), gray trousers. The forage cap should be gray or covered with a Havelock. A white haversack, weapon and accruements as described above.

<u>2<sup>nd</sup> Alternate:</u> Grey battle shirt as per BHB which is a three button, block style placket shirt of gray cotton. This shirt should be made with hand sewn button holes and bone or wood buttons. The forage cap should be gray or covered with a Havelock. A white haversack, weapon and accruements as described above.

<u>3<sup>rd</sup> alternate:</u> This will require the 2<sup>nd</sup> Wisconsin to form another company for the event. It should also provide the least amount of money to take the field. The only request that I have is that this impression take the field with dark blue trousers per requirements of an Antietam impression without the white gaiters. This should enable any member who is considering the 1862 campaign the opportunity to purchase dark blue trousers at this time and be with-in guide lines for next year.

As we consider our attendance at this year's National Event, keep in mind while we proceed to our school events and other presentations that the Second Wisconsin had a variety of uniforms prior to their famous black hats. As you talk about the Second Wisconsin's history, remember to explain that they wore their towns' militia uniform from where came and the Wisconsin gray uniforms during their first major battle of the war. There is so much to learn as we study our regiment's history. History has a lot to teach us. Let's study it well, so we may teach it appropriately.

#### **IV. Board and Military Officers Report:**

- A) Board President/Lt Col.: given by Pete Seielstad
  - 1) Pete Seielstad gave a vote of thanks to Jim Dumke for the printing and handling of the Fugelman and for his professionalism.
  - Pete reported that Communication was very good the past year amongst the Company's, the Association and between the members. Need to keep up the good work on Communication
  - 3) Pete also stated that the Association (including Officers) had become to laxed at some of the events. (one being Norskedalen) Would like to see a better Military decorum at events.
  - 4) There were several safety issues and some members (because of these issues) were hurt in the past year. The members need to be more diligent and more aware of safety and practice it better.
  - 5) Pete also thanked David Dresang Jr., Scott Frank and Terry Brown for all their assistance and help to Pete while he served as President. He could count on the board for their help and support.
  - 6) The members need to remember that we (as an Association of the 2<sup>nd</sup> WI) need to be aware of the fact that we do portray the original 2<sup>nd</sup> Wisconsin men and we need to be diligent in our efforts to accurately portray them
- **B)** Secretaries report: given by David Dresang Jr.
  - 1) David reported that in 2010 the Association had 164 members that compares to 151 members in 2009
  - 2) David also reported that Company C (out of New Jersey) had disbanded for the year of 2010 but were going to look to 2011 to try to reform the Company and re-join the Association.
  - 3) Membership cards are available and every Company representative was asked to pick their cards up before the end of the meeting. The membership cards (top portion) need to be filled out by either the treasurer or the Company Secretary before giving the cards out.
  - 4) David also reported that the Association has been contacted and invited to many events or invited to join other reenacting groups for the year of 2011, this is in conjunction with the start of the 150<sup>th</sup> anniversary of the beginning of the Civil War.
  - 5) David brought up that the biggest complaint that he received this past year was from those that wanted to take part in the scholarship program but many did not because they said the part about the essay was confusing. The requirement reads:

"Attach a separate sheet, containing a short essay (500 words or less) on the following topic. "How do the events or idea of the Civil War continue to affect the United States today?" He also had informed the scholarship committee of these concerns to see if they could be addressed.

Pete Seielstad Company B (as the tie breaking judge if needed) This past year's recipient was Eric Blasing from Company B

6) David also thanked the Association for the opportunity he had by serving as Secretary for the past 8 years

#### C) Major of Infantry Doug Rasmussen:

- 1) Doug expressed gratitude for the opportunity of being Major. He stated that he only gets that opportunity 2 to 3 times a year and enjoys it very much
- 2) Doug thanked everyone for their support and hard work.
- 3) Spring Muster is his most enjoyable event as Major
- 4) The men did a very good job at spring Muster and the maneuvers they were asked to perform, because of this and the quick way the members learned he was able to get in more advanced drill for the men.
- 5) The drills that were learned at Wade House Spring Muster showed everyone at other events (Wade House and National events) how well prepared the men really were and to keep up the good work.

#### D) Company Officers/Presidents reports

- 1) Company A: given by Scott Frank
  - a. Company A has 2 members and that 100% of the Company showed up for the meeting
  - b. Company A members did preservation work at Gettysburg, they made 2 trips out there, 1 in Spring where they had 8 men show-up and in the Fall where they had between 10-12 men.
  - c. Tom Klas is going to be a father (in March?) for the 3<sup>rd</sup> time
  - d. Scott Frank is married to his work, but they will do their best to help support the Association events
- 2) Company B: given by John Dudkiewicz
  - a. Company B has 14 members in the Association and a total of 20 on their roster
  - b. Norskedalen is B's big event which will be October 8<sup>th</sup>-9<sup>th</sup>
  - c. Charles Woods has dropped out of Company B and some of the members that join B come from Ft. McCoy, so they will loose and gain members due to transfers.
  - d. Tom Filgrave is being transferred from Ft. McCoy to Virginia?
  - e. John then presented the members (at the meeting) a brief history of the original Company B regimental flag.
  - f. Company B has replicated the flag to almost look exactly as the original one.

- g. The original flag was presented to Company B on July 4<sup>th</sup>, 1860 by the ladies of La Crosse.
- h. Company B was known as the "La Crosse Light Guard"
- i. The flag did go with Company B to Washington D.C. but they had to leave it with the War Department when they were sent off to war. The flag was stored in the basement of the War Department where it stayed until a Congressman form La Crosse came across it and had it sent back to Wisconsin.
- j. The flag was brought back to La Crosse where it became lost. It was later found and in 1930 it was conserved and then put on display at the La Crosse Courthouse.
- k. The flag is 2 sided with the State Seal on one side and the Ladies of La Crosse on the other. All members of the Company had their names put on the flag with the exception of 13 men who had deserted at some point during the War and 2 men who were found to young to fight. One name was actually a member of Company K and a mystery surrounds why he had his name on the flag.
- 1. Once again the flag disappeared and in 1994 was recovered.
- m. Company B (Association members) raised \$5,000.00 to have it conserved once again and the original flag now exists at the Courthouse.
- n. Pete Seielstad pointed out that the Association needs to be more involved in such work, he used the example of Company E where they held a charity march and Company A's efforts at Gettysburg.
- 3) Company C: given by Bill Acheson and read by Pete Seielstad
  - a. Effective immediately, I am stepping down from all reenacting duties For awhile-Bill Acheson 2/6/2010
  - b. Company C has disbanded, no one has stepped up to take my place so we Will not be part of the Association for the scheduled year of 2010. I will take a look after my break and see if there is an interest for the 2011 season-Bill Acheson
  - c. Pete Seielstad expressed that this was sad news, loosing Company C but At the same time it was good news in the fact that they still have some interest.
- 4) Company E: given by Dave Sielski
  - a. Company E has 35 military members and had 4 new members join last year
  - b. Company E also has a Father and Son from Canada wishing to join
  - c. The Charity March brought in \$625.00 this past year. It is a 2 day March and was held on the property of a member of E who has a lot of land. On Saturday of the March it was known as "The mud March"
  - d. The money was donated to the Kings Home and went for the up keep and repair of wheelchairs.
  - e. Heritage Hill (June 25<sup>th</sup> -26<sup>th</sup>) is E's big reenactment and Dave invited all to attend the event. It started last year and the event organizers form Heritage Hill were very pleased and had about 500 more spectators show up than they had originally thought would come.

- f. Neville Public Museum in Green Bay is having a special event entitled "Badger Boys from Wisconsin" to help commemorate the 150<sup>th</sup> anniversary of the beginning of the Civil War, they are having their Grand Opening of the event on February 4<sup>th</sup> 2011 and all are welcomed to see the exhibit while it is at the Museum.
- 5) Company G: given by Gary Klas
  - a. Company G has 2 members
  - b. The big thing for G will be preservation, especially of its members
- 6) Company H: given by Tom Bispo read by Pete Seielstad
  - a. Company H has 15 regular members and 16 associate members, of which 12 are military. Company H has lost several military members over the years, but they have also gained new members and had former members return. The membership has stayed fairly constant over the past 4 years.
  - b. Company H remains a tight-knit, dedicated unit that enjoys the camaraderie of reenacting and is proud of it's identity as 2<sup>nd</sup> Wisconsin V.I. members.
  - c. Company H has 11 official events listed on their calendar for 2011
  - d. In addition to battlefield events, there are 2 school events, 3 National Park living history events and a Memorial Day ceremony in honor of all veterans of America's wars in Santa Cruz, CA.
  - e. January 29<sup>th</sup> they will kick off the 2011 reenacting year with living history day at Fort Point, San Francisco. This National Park site is the only Civil War era brick and masonry fort on the West Coast. The fort stands at the entrance to San Francisco Bay beneath the Golden Gate Bridge. It is similar in construction and appearance to Ft. Sumter, and has remained intact event to this day, although it was threatened many times by the wrecking ball.
  - f. Company H attendance at this first event of the year promises to be the highest in recent memory, hopefully a harbinger of a great year to come.
- 7) Company K: given by Ugljesha Pirocanac
  - a. It was an active year for Company K especially supporting her sister Company events, along with their own.
  - b. Company K will be having a major school day on May 20<sup>th</sup> There will be 20 stations; they are looking for help from anyone interested in joining them
  - c. Last year 2200 students attending the school day and they expect the same this year.
  - d. They have had help from a signal company from Illinois along with General & Mrs. Grant.
  - e. It is a very comprehensive event dealing in more active stations and participation from the students.
  - f. They will have a Medical Station along with several Infantry Stations.
  - g. The event is at Blue Mound State Park.
  - h. Companies K has 35 military members and are holding steady at that number.

#### E) Major of Artillery Brant Doty

- 1) Battery B has 18 members and 1 new member
- 2) John Utterback was promoted from Gun Sgt. to Ordinance Sgt.
- 3) At Battery B's annual meeting several awards were passed out.
  - a. Thomas Sobottke (who has been very ill the last several years with cancer) was given a certificate of Appreciation for his work and dedication.
  - b. The KEARNEY Cross was given to Walter Hlaban for his action at Heritage Hill saving the field piece from being captured.
- 4) A copy of the contract between the 2<sup>nd</sup> Wisconsin and the National Guard was located and a copy has been secured for the Association. It dates back to 1994. e) The only request made was to find a more secure place in for those in Madison that would take the bus. Last year 2 members had their vehicles vandalized at the Park & ride that was used.

#### 5) Uniform Requirements

- a) The Association will be divided into 2 groups, those who wish to go as the 2<sup>nd</sup> Wisconsin wearing the State Militia gray uniforms will be under the Command of Pete Seielstad, those who can't afford the required uniform, they can go blue and they will be under the Command of Doug Rasmussen.
- b) Tom Klas was asked to present examples of the gray uniform that those who wished to go as the 2<sup>nd</sup> WI would be required to wear.
- c) Smatterings of state issued and federal issued uniform & equipage. some items of known prevalence include the state issue haversacks of heavy white duck with blue stripe and leather closures, state issued seven inch canteens, the double brimmed shako or kepi as the soldiers removed the whale and wire stiffeners, and the gray coat frock coat & trousers encompassing a wide variety of differing materials & patterns that were generally light gray in color to medium gray. Federal leather accouterments, state issue or civilian blanket, Pattern of 1816/1822 Harpers Ferry Conversion Musket in .69 caliber or & Pattern 1855 Maynard Rifle-Musket in .58 caliber issued in Company B. According to Captain Thomas Allen, knapsacks were left behind. Also Allen points out all officers were clad in gray as they packed away their best uniforms of blue.
- d) Jerry Letcher asked if it would be possible to get the patterns of the frock coats and trousers, Jerry knew of a person that could make the clothing at a reduced cost.
- e) Ugljesha Pirocanac asked about the black piping that was worn on the trousers. Tom said that the 2<sup>nd</sup> Wis. Did have black piping down the trousers that were 1/8" wide and if you wished to put it on, that would be great but not necessary, also the NCOs' had black chevrons.
- f) Tom also said that the leathers that we wear are just fine, but the haversack was white with 2 buttons, one on each end of the flap.
- g) For those that prefer to go blue, the current uniform is fine, frock coat would be better than the sack coat if possible as the sack coat didn't come out until 1862
- h) Also a forage cap (for those in blue) would be preferred, and no leggings to be worn.

- i) Tom will issue an approximate price for the items for those that wish to go gray. He gave some prices but they are from 2007 so the prices have probably gone up.
- j) Gray frock coat \$200.00-300.00
- k) Trousers?
- 1) Haversack \$50.00
- m) Canteen \$80.00
- n) Kepi \$100.00
- o) You would not have to get any kind of special Musket, the one that you have would do just fine.
- p) the state issue frock coat should have:
   Gray cloth, plain single breast, hand sewn buttons and buttonholes, nine federal eagle buttons attached in the front, a standing collar, tail pockets with two federal eagle buttons affixed, and *without* piping or welting on the collar and cuffs. Coat should be lined.
- q) Trousers should be light gray in color, hand sewn buttons and buttonholes. Militia pattern preferred. If you want a black stripe down the seam as in the original trousers, this can be had but for an additional fee. Materials of jean cloth, satinette, or broadcloth. The state prescribed the following regarding trousers: Gray cloth, plain, black welt 1/8 inch wide in the outside seam.
- r) The ONV had a series of caps made for the Park City Grays based on the 7<sup>th</sup> New York militia cap and that pattern was similar except for the double brim in the 2<sup>nd</sup> Wisconsin's cap. These will be without the stiffeners, have the black strip across the circumference of the cap as seen in the 7<sup>th</sup> New York cap, and the double brim but they can add for an additional cost however I do not feel this should be required. Lined, hand sewn leather sweatband, thin painted leather black brim with no edging, leather chin strap, and two 5/8 inch general service eagle buttons attached on each side of the chin strap. The state prescribed the following regarding caps: Gray cloth, 7<sup>th</sup> Regiment style- patent leather strap.
- s) I have met with Bill Brewster to see if we can put together an order for Pat Cunningham to make these canteens based on one in the WVM. Pat makes the current tine ware for the WVM. I should have an answer by early March but with Bill not at the WVM anymore, I do not know if this will be possible. I will send updates and I find out more information. Secondary choice would be federal issue but these would have been a rarity in the ranks. If federal issue is used, avoid bulls eye canteens as these were not in production in 1861. Also the leather canteen strap for federal issue was the standard for New York and Schuylkill Arsenal. – not the cotton strap.
- t) I will be in contact with Richmond Depot to see if they can make the state issue haversack as documented. This was untarred, white with blue ticking strip on the strap. I should have an answer soon on this. If we can not have this made, Richmond Depot would make an

acceptable alternative cotton haversack with button closure as a secondary choice. Tarred haversacks would not have been seen until after Bull Run for those whom lost these items during the battle, therefore the current tarred federal issue should be avoided.

u) We have no solid documentation at this time on the state issue blanket other than soldiers stated they were of heavy wool. I recommend getting a good 100% wool blanket with hand sewn edges if a folded edge is used. Can be in solid colors (stick to dull colors – earth tones) or solid and stripes, with varying dimensions. These blankets should be around 3-4 lbs. in weight to keep you warm. Civilian Coverlets made of wool and cotton is also appropriate for use as a gift from the home front. Hand sewn boarders with documented patterns, construction, and materials. Federal issue blankets should be avoided as the Second Wisconsin had the state issue blanket for Bull Run.

# AN ARTICLE FROM THE NEW YORK TIMES ABOUT THE FAMILIES OF THE MEN STATIONED AT FORT SUMTER

### February 4, 2011, 9:00 pm Women and Children First By ADAM GOODHEART

Off Cape Hatteras, Feb. 5, 1861

It had already been a long voyage. For almost two full days, the little steamer Marion had lain at anchor at the mouth of Charleston Harbor, waiting for the weather to clear. Winter rain spattered against the decks and landed, hissing, on the boilers' iron flanks. Below, several dozen unhappy passengers huddled in the dimness, mothers consoling their wailing children or staggering over to the portholes to be sick.

But on Feb. 3 they had emerged resolutely above decks, despite the weather, as the steamer passed the high walls of the fortress where they were leaving behind their loved ones. There, silhouetted against the gray sky, were Fort Sumter's defenders, their husbands and fathers. From atop the parapet of Sumter came three rounds of throaty cheers. The women and children, many choking back tears, bravely shouted three cheers in reply.

Then the boat chugged on and Sumter, out of earshot, dropped away astern. "The men lingered upon the parapet until the vessel was lost to view on the horizon," an officer wrote. The wives and children of the Union garrison's enlisted men were headed away from secession and revolution, away from impending war, toward safety in New York.

The role of women in the Civil War began much sooner — and much more dramatically — than most later accounts suggest. At Fort Sumter, wives and children suffered the fears, privations and hard work of the siege for more than a month, alongside the small force of officers and men under Maj. Robert Anderson. They were even on the battlements when the first shots of the war were fired — and came close to participating in the combat themselves.

In the prewar Army, it was commonplace for the fighting men's wives and children to accompany them from one posting to another. Few first-hand accounts survive, though, perhaps because common soldiers were almost always poor, and usually immigrants, and it is likely that many of them and their spouses were illiterate. Still, we know a good amount about the lives of the women and their families during those months at Fort Sumter.

By late January supplies were running short; the privates had been put on half-rations, while their officers — though not deprived to the same degree — were going without coffee. And the warlike preparations around them grew more and more ominous: the rebels sank hulks in the mouth of Charleston Harbor, while slaves constructed a formidable-looking, bombproof battery at the tip of Morris Island.

Moreover, some of the besieged families at Sumter apparently had reason to feel anxious not just for themselves, but also for the besiegers. One of the Union corporals had a son among the Confederates on Morris Island, while a soldier's brother had enlisted in the secessionist Palmetto Guard. "If war comes," The Times's correspondent wrote presciently, "a father may point at the heart of a son, and brother may meet brother in deadly conflict!"

As for the officers' families, most had already been separated from their loved ones for over a month. In late December, just before withdrawing into Sumter from their original post at Fort Moultrie, the officers had sent their wives and children over to the mainland, seemingly out of harm's way. Mary Doubleday, the wife of Capt. Abner Doubleday, had taken hasty leave of her husband, with barely enough time to throw her clothing into a couple of trunks before embracing him sadly — for, as her husband later recalled, "neither knew when or where we would meet again." She spent that long night pacing up and down the beach, peering anxiously toward Sumter.

Mrs. Doubleday was not one to be kept apart from her husband for long, however. On the afternoon of Jan. 3, she surprised Abner by appearing at Sumter's wharf, bundled up against the intense cold, perched in the stern of a longboat rowed by some civilian laborers returning to the fort. (For the time being, at least, South Carolina's authorities had decided not to interfere with these workmen's comings and goings.) Two other officers' wives managed to come over separately that day. Captain Doubleday was delighted, but also somewhat nonplussed: in the harsh conditions of the beleaguered fort, with lamp oil and fuel already almost depleted, the ladies could hardly be entertained in the comfort to which they were accustomed. Gallantly, he chopped up a handsome mahogany table in his quarters, burning it for fuel "to keep my wife from suffering during her brief visit."

According to an account that emerged weeks later in The Times and other newspapers, Mrs. Doubleday and Louisa Weir Seymour, the wife of Capt. Truman Seymour, repaid such hospitality by smuggling over "a number of articles, including a box of candles, intended for the use of their friends in the garrison." (The report denied rumors that the ladies had indelicately concealed this precious contraband under their hoop skirts, however.)

Mrs. Seymour, who came from a prominent family of American painters, was as redoubtable a character as Mrs. Doubleday. While at Sumter, she reportedly begged Major Anderson for permission to stay and help load cannons or care for the wounded when the inevitable assault on Sumter came. "The request was, for reasons which were to the Major manifest, respectfully denied," a letter in The Times reported.

Despite this refusal, at least one of the women did nearly experience combat – indeed, she very nearly fired a shot that could have touched off the Civil War three months early. On Jan. 9, one officer's wife her identity was not recorded — was present with the Union troops on the ramparts when they watched, helpless, as Confederate gunners lobbed cannonballs at the steamer Star of the West, which was unsuccessfully attempting to bring provisions and reinforcement. Less willing than the men to suffer this assault without retaliating, she seized the lanyard of a loaded cannon, intending to fire back at the rebel battery. The quick-thinking Doubleday stayed her hand.

Even after they left Sumter, Mrs. Doubleday and the other officers' wives continued to fight on the garrison's behalf. They went immediately to Washington, where they funneled information about the besieged garrison to President James Buchanan and to Presidentelect Abraham Lincoln.

As for Major Anderson's wife, she, too, played a role in the armed standoff. Eba Anderson, who suffered chronic ill-health, had remained behind in New York when her husband took over command in Charleston Harbor. But one day in January, the mail boat from Charleston to Sumter dropped her off unexpectedly at the fort's wharf. Worried by the lack of mail from her husband, the major's Georgiaborn wife had traveled by train from New York to see him, and received permission from the rebel authorities because, as Doubleday wryly put it, "she had many influential relatives among the Secessionists."

Eba Anderson stayed only two hours — barely long enough to assure herself that her husband was safe and to take a meal together — but with her had come another visitor who would remain for three months. Peter Hart, a tough former sergeant, had accompanied the major as his orderly all through the Mexican War. Remembering her husband's fondness for him, the resourceful Mrs. Anderson had decided to track him down. She found Hart serving as a New York City policeman in a remote district of Upper Manhattan — just above 26th Street, that is — and somehow persuaded him to join the defenders at Sumter. The rebels refused at first to let Hart stay, but when Mrs. Anderson persisted, they gave in, on the condition of his word of honor not to fight as a soldier. This he gave, but he would still play an important role in the battle to come.

On Feb. 6, the steamer Marion at last drew up to a wharf in New York Harbor. Newspaper correspondents were waiting to interview the enlisted men's wives as they disembarked. A Times reporter wrote:

With few exceptions, they appeared in good spirits, and some of them even in cheerful humor, and were not at all inclined to put a bad face upon affairs in Sumter. The more intelligent and thoughtful among them, however, appeared anxious and care-worn. They had taken leave of their husbands with heavy hearts and might never see them again. ... Great anxiety was evinced by them to know the course events were likely to take, and the most earnest wishes were expressed that affairs might be peaceably settled, and without bloodshed.

## HISTORY OF THE 2<sup>ND</sup> WISCONSIN VOLUNTEER INFANTRY UNIFORM & EQUIPAGE AT FIRST BULL RUN

Hi gents,

Lt. Col. Pete Seielstad asked me to provide this primer of the uniform & equipage of the 2<sup>nd</sup> Wisconsin for the upcoming Bull Run reenactment in 2011. I have put together a small history and potential sources to get the accurate gear while keeping costs in mind too. Having put together a portion of this kit for the Park City Grays back in 2007, I have a pretty good idea for where to go for accurate reproductions of state militia issue clothing and equipage. I invite all members to read Howard Madaus' *Appendix III: Uniform of the Iron Brigade at Gettysburg July 1, 1863* in Lance Herdegen's book In the Bloody Railroad Cut at Gettysburg for a fine overall summary of the uniform and equipage of the 2<sup>nd</sup> Wisconsin in both 1861 and beyond.

Review of Uniform & Equipage on July 21<sup>st</sup>, 1861

Smatterings of state issued and federal issued uniform & equipage. Some items of known prevalence include the state issue haversacks of heavy white duck with blue stripe and leather closures, state issued seven inch canteens, the double brimmed shako or kepi as the soldiers removed the whale and wire stiffeners, and the gray coat frock coat & trowsers encompassing a wide variety of differing materials & patterns that were generally light gray in color to medium gray. Federal leather accouterments, state issue or civilian blanket, Pattern of 1816/1822 Harpers Ferry Conversion Musket in .69 caliber or & Pattern 1855 Maynard Rifle-Musket in .58 caliber issued in Company **B.** According to Captain Thomas Allen, knapsacks were left behind. Also Allen points out all officers were clad in gray as they packed away their best uniforms of blue.

Captain Thomas Allen also states, "....for we were all dressed in the dilapidated gray with which we left our state," from his article <u>The Second Wisconsin at the First Battle of Bull Run.</u> Read October 1, 1890. This means although the 2<sup>nd</sup> received their summer uniforms of cottanade in July, these were not taken along due to cool nights as written by Alan Gaff in his book <u>If This is War</u>, page 165. This is supported by Allen's remarks noted above and not the new cottanade uniforms that Charles C. Dow discussed in his letter dated on July 10<sup>th</sup>, 1861. Because of this I would avoid looking at cottonade uniforms at this time unless more documentation proves it self. My recommendation would be to go with the wool state frockcoat and trowsers issued while in Camp Randall.

Here is a link to the Oshkosh Museum Virtual Museum showing Corporal Walker Rouse in his state issue uniform in Washington from 1861. Just a heads up the leggings worn are private purchase and not state issue to my knowledge.

#### <u>State Issue Frockcoat & Trousers.</u>

The 2<sup>nd</sup> Wisconsin frockcoats would be of similar pattern, material, and construction to the ones worn by the 1<sup>st</sup> Wisconsin Volunteer Infantry 90 day regiment. An existent state issue frockcoat as worn by Sergeant Warren M. Graham of Company "B" 1<sup>st</sup> Wisconsin Volunteer Infantry Regiment is in the holdings of the Milwaukee Public Museum. Based on this coat and standards put forth by the state, the state issue frock coat should have:

Gray cloth, plain single breast, hand sewn buttons and buttonholes, nine federal eagle buttons attached in the front, a standing collar, tail pockets with two federal eagle buttons affixed, and *without* piping or welting on the collar and cuffs. Coat should be lined.

If you want to have Dan Wambaugh – W, W, & Company or Richmond Depot to make the 1<sup>st</sup> Wisconsin reproduction frockcoat based off of the one in the Milwaukee Public Museum (we sent them both pictures and measurments), ask for details and cost. In 2007 we had these coats made for around \$300.00 from Dan and \$400.00 from Richmond Depot. Here is a link to the Milwaukee Public Museum Virtual Tour – look for the Warren M Graham frock coat to see the coat for yourself that would be very similar to the 2<sup>nd</sup> Wisconsin's state issue frock coat.

If you want to *save money*, get an enlisted Confederate frock coat from the below vendors with federal eagle buttons since the patterns and construction features are very similar to militia and state produced frockcoats as seen in the Graham frock coat. Coats were of all different shades of light to medium gray due to the contractor whom procured these items for the state. Made of light gray jean, satinette or broadcloth

Trousers should be light gray in color, hand sewn buttons and buttonholes. Militia pattern preferred. If you want a black stripe down the seam as in the original trowsers, this can be had but for an additional fee. Materials of jean cloth, satinette, or broadcloth. The state prescribed the following regarding trowsers: Gray cloth, plain, black welt 1/8 inch wide in the outside seam.

Where to Buy. - Discounts can be arranged for group purchases

Wambaugh, White, & Company – Note Dan has a package deal for Standard Grade Confederate Frockcoat and Trowsers for \$485.00. Also ask for the Park City Grays frockcoat if he can make on for you based on the Warren Graham frockcoat in the Milwaukee Public Museum.

*Stony Brook Company - Chris Sullivan* – Chris can make trowsers in museum grade or commercial grade (cost savings) depending on your budget. Also offers group discounts.

## **<u>Gray Kepi/Shako with black stripe</u>**

The ONV had a series of caps made for the Park City Grays based on the 7<sup>th</sup> New York militia cap and that pattern was similar except for the double brim in the 2<sup>nd</sup> Wisconsin's cap. These will be without the stiffeners, have the black strip across the circumference of the cap as seen in the 7<sup>th</sup> New York cap, and the double brim but they can add for an additional cost however I do not feel this should be required. Lined, hand sewn leather sweatband, thin painted leather black brim with no edging, leather chin strap, and two 5/8 inch general service eagle buttons attached on each side of the chin strap. The state prescribed the following regarding caps: Gray cloth, 7<sup>th</sup> Regiment style- patent leather strap.

## **State Issue Tin Canteen**

I am meeting with Bill Brewster to see if we can put together an order for Pat Cunningham to make these canteens based on one in the WVM. Pat makes the current tin ware for the WVM. I should have an answer by early December.

Secondary choice would be federal issue but these would have been a rarity in the ranks. If federal issue is used, avoid bulls eye canteens as these were not in production in 1861. Also the leather canteen strap for federal issue was the standard for New York and Schuylkill Arsenal. – not the cotton strap.

## <u>State Issue White Haversack</u>

I will be in contact with Richmond Depot to see if they can make the state issue haversack as documented. This was untarred, white with blue ticking strip on the strap. I should have an answer soon on this. If we can not have this made, Richmond Depot would make an acceptable alternative cotton haversack with button closure as a secondary choice. Tarred haversacks would not have been seen until after Bull Run for those whom lost these items during the battle, therefore the current tarred federal issue should be avoided.

Richmond Depot (should have an answer by December if they can make) .69 Caliber Harpers Ferry Conversion Musket & other options I will leave this up to the group, however there is not a good reproduction source for the cone in barrel conversion .69 caliber Harpers Ferry. For those looking for a project, Pedersoli carries a flintlock Hapers Ferry that can be converted to cone in barrel or french drum conversion. Gunsmith Todd Watts whom can be contacted through the Blockade Runner Sutler would be an excellent source to defarb on these conversions. Another option for the .69 caliber weapon would be to go with the less expensive 42 Springfield. A third option knowing Company B had 55 Springfield's would be to have 61 Springfield reproductions also in .58 caliber to be a close substitute.

### <u>Federal Leather Accouterments</u>

Should have Pattern of 1857 or 1861 .69 caliber cartridge box, shield front cap box, and sewn or two rivet scabbard for your bayonet. Can use normal waist belt and cartridge box belt (sling). If using a Springfield, no need to purchase the .69 caliber federal leather accouterments – use what you have for be correct for the .58 caliber rifle-musket. Here is a quote on our Website concerning *accouterments* from Monday, June 24th of 1861 on the Second's arrival in Harrisburg, PA. It is from an unknown 2nd Wisconsin soldier:

About noon, Col. Coon received a telegram from the Secretary of War containing an order on the Harrisburg Arsenal for our muskets and 40 rounds of ball and buck shot cartridges, and directing the Regiment to proceed to Washington immediately. It was a busy time for us the balance of the day and, in fact, nearly all night it is not a small job to distribute arms accoutrements and ammunition to 1,000 and we did not leave for Baltimore till 1 o'clock.

## <u>State Issue Blanket or Civilian Coverlet:</u>

We have no solid documentation at this time on the state issue blanket other than soldiers stated they were of heavy wool. I recommend getting a good 100% wool blanket with handsewn edges if a folded edge is used. Can be in solid colors (stick to dull colors – earth tones) or solid and stripes, with varying dimensions. These blankets should be around 3-4 lbs. in weight to keep you warm. Civilian Coverlets made of wool and cotton are also appropriate for use as a gift from the homefront. Hand sewn boarders with documented patterns, construction, and materials. Federal issue blankets should be avoided as the Second Wisconsin had the state issue blanket for Bull Run.
